2. The promoted officers are required to assume charge of the promoted post of SO within 7 working days from the date of the promotion order. If any officer fails to assume charge of the post within 7 working days of issue of the order, his/her adhoc promotion will be liable to be cancelled. However, those officers who are on short term (less than 3 months) leave, training etc. on the date of issue of promotion order shall assume the charge of the post immediately on joining from such leave, training etc.

- 3. Further, the promoted Section Officers will be posted temporarily on as-is-where-is basis till further Orders.
- 4. The appointment of the above officers to the post of Section Officer on ad-hoc basis is subject to the following conditions:
 - i. The period of adhoc promotion would be **upto 31.12.2023** or until further orders, whichever is earlier.
 - ii. The adhoc promotion shall not confer any right to continue in the grade indefinitely or for inclusion in the Select List for regular appointments or to claim seniority in the Section Officers' Grade of CSS or for promotion to the next higher grade or for grant of NFS.
 - iii. The adhoc appointments shall be temporary and may be terminated at any point of time without assigning any reason there-for.
 - iv. The officers so promoted and not yet completed the Level B training successfully or not falling in the exempted category, would successfully complete the mandatory Level B training programme as and when nominated to DoP&T. Failure to do so may attract disciplinary action including reversion to their substantive post of ASO.
 - v. The said ad-hoc promotions of SO will be further subject to the outcomes in CA No. 629/2022 and related cases pending with Hon'ble Supreme Court in reservation matters and orders of any competent court in any connected matters and seniority /promotion matters in SO/ASO/SSA grades pending before any competent court.
