OFFICE MEMORANDUM

SUBJECT: Demands projected by the Defence Recognized Federations.

In response to the 6th CPC's call, various Federations/Associations/Organizations submitted their Memoranda projecting their demands to the Commission. Ministry of Defence also forwarded photocopies of these Memoranda to the Commission from time-to-time.

2. With a view to ensuring that the demands and aspirations of all the employees of this Ministry were projected to the Commission, Joint Secretary (O/N) and Ministry's Nodal Officer for matters to the 6th CPC took a meeting with the representatives of the Defence recognized Federations/Organizations on 11.04.2007. The Federations were requested to highlight important issues, which needed specific attention of the Commission. A copy of the Minutes of the Meeting Chaired by JS(O/N)/MoD on 11.04.2007 is attached for ready reference.

3. Rather than adhering to the contents of their memoranda already under submission to the 6th CPC, the four Federations have projected additional demands in their communications addressed to JS (O/N) in connection with the meeting of 11.04.2007. One Federation, namely the Bhartiya Pratiraksha Majdoor Sangh (BPMS), has vide its Memorandum No.BPMS/MOD/6th-CPC/07 dated 10.04.2007 repeated the responses it had made in connection with the 6th CPC's Questionnaire. The Federations had also made presentations and interacted with the Commission.

4. Ministry of Defence, therefore vide ID note dated 20.07.2007 requested the Federations to confirm whether they had submitted/discussed these issues in their Memorandum or during their communication/presentation to the 6th CPC. Except the All India Defence Worker Federation, the other three Federations have replied the MoD ID note dated 20.07.2007.

5. The replies received from the Federations - which are self contained - are forwarded herewith for consideration.
