Subject: Farming/amendment of Service Rules/Recruitment Rules as per Seventh Central Pay Commission's recommendations- regarding.



On implementation of 7<sup>th</sup> CPC recommendation, CCS (Revised Pay) Rules 2016 have been issued by Department of Expenditure vide Notification dated 25<sup>th</sup> July, 2016.

2. In this connection DOPT has issued an OM dated 9th August, 2016 regarding amendment of service Rules/Recruitment Rules by replacing the existing Pay Band and Grade Pay with the corresponding Level in the Pay Matrix in the revised pay structure recommended by the 7<sup>th</sup> CPC.

3. In order to streamline the matter in time bound manner, a meeting was held in DOPT with the administrative Ministries/Departments to review the progress in the implementation of the OM. An important suggestion made in the meeting was with respect to facilitating the process of consultation with the Legislative Department for drafting notification for amendment of RRs in accordance with OM dated 9<sup>th</sup> August, 2016 and its Hindi translation so as to expedite the issue of amendment notification. In this regard, DOPT in consultation with Legislative Department has prepared a model notification in English and Hindi for use of the Administrative Ministries/Departments. These are annexed at Annexure-I and Annexure-II.

4. All the service Head quarters/Departments concerned are, therefore, requested to submit their proposals for amend the notified RRs as per DOPT OM dated 18/1/2017 (copy enclosed and also being uploaded in MoD's website under "Employees Corner" of DOD, Ministry of Defence Order <http://www.mod.nic.in/forms/sublink1.aspx?lid=2318&Id=56>) **following the language annexed at Annexure-I and Annexure-II with a certificate that the amendment proposed is only to incorporate the instruction issued by DOPT OM dated 9/8/2016 and 18/1/2017.** This exercise should be completed by 15<sup>th</sup> March 2017 positively. If there are other amendments in existing RRs, besides the amendments suggested in the above OM, the proposal may be submitted separately for regular revision/amendment as per laid down procedures.
