

**REVISION OF MSI-2018**

1. The Manual of Security Instructions (MSI) 2018 has been in vogue since 01.01.2019. The MSI-2018 comprises three parts namely Part-I Security Instructions, Part-II General Instructions for Issue/Custody of Access Documents and Part III Fire Orders. MSI is the key document for regulating concerns related to physical and cyber security of MoD along with all its constituents functioning from the DHQ Security Zone. In view of recent developments such as the promulgation of MoDNet Cyber Security Policy, shifting of office accommodation from Hutments to Africa Avenue and KG Marg<sup>etc.</sup>, a need for review of the MSI has arisen. This also presents an opportunity for the Security Office to seek feedback/suggestion from all concerned for systemic improvement.
