Sub: Revision of Sea Going Allowance in respect of Indian Navy.

Sir,
I am directed to convey the sanction of the President for Implementation of the following decisions taken in this regard in so far as the officers and JCOs/OR of Navy are concerned:

2. The Government has agreed to revise the rates of Sea Going Allowance as per cell R1H1, R1H2, R2H2 and R3H1 of the Risk & Hardship Matrix as given in column III for platform/ operations mentioned at column II of the table given below:


