Subject: Extension of suspension of business dealings with M/s Vectra Advanced Engineering Pvt. Ltd (VAEPL) for a period of six months w.e.f. 14.02.2023 in terms of the 'Guidelines of the Ministry of Defence for penalties in business dealing with entities'.

Vide MoD ID Note of even number dated 14.08.2020, with the approval of Hon'ble Raksha Mantri, business dealings with M/s Vectra Advanced Engineering Pvt Ltd (VAEPL) were suspended for a period of one year with effect from 14.08.2020 in terms of Para D2 of the 'Guidelines of the Ministry of Defence for penalties in business dealing with entities' issued vide MoD ID Note No. 31013/1/2016-D(Vig.) dated 21.11.2016.

- 2. The above period of suspension was reviewed under extant provisions and with the approval of Hon'ble RM, the period of suspension was extended by six months w.e.f. 14.8.2021, vide MoD ID Note of even number dated 3.9.2021, again by six months w.e.f. 14.02.2022 vide MoD ID Note of even number dated 10.01.2022 and again by six months w.e.f. 14.08.2022 vide MoD ID Note of even number dated 10.08.2022.
- 3. The period of suspension of business dealings with M/s VAEPL has further been reviewed under the extant provisions and with the approval of Hon'ble RM, the period of suspension has been further extended by six months beyond 14.02.2023 in terms of Para D3 of the MoD Guidelines dated 21.11.2016.
- 4. It is requested that strict compliance of the above decision may be ensured by all Wings in this Ministry and Service Headquarters.
