### Subject: Delegation of Financial Powers to NHQ - Enhancement of Powers of VCNS in NSP 2016

The matter regarding higher financial powers to the Vice Chief of Naval Staff (VCNS) has been under consideration in Ministry of Defence. With the approval of Raksha Mantri and concurrence of Financial Advisor (Defence Services), the financial powers delegated to the VCNS are hereby enhanced in respect of various sub-schedules of Navy Schedule of Powers (NSP)-2016 as per Annexure A to this order. In case of some sub-schedules where VCNS was not the CFA, VCNS has been included as higher CFA with enhanced powers. NSP-2016 shall be considered to have been amended as per Annexure A.

2. Requisite amendments to DFPM-2015 as a result of higher powers delegated to VCNS shall be issued in due course.
