REQUEST FOR INFORMATION

LIFE EXTENSION OF 300MM SMERCH ROCKETS (04 VARIANTS) FOR INDIAN ARMY BY PRIVATE INDIAN VENDORS

General

1. The Master General of Sustenance, Integrated HQs of Ministry of Defence (Army), invites Request for Information (RFI) for life extension of SMERCH ammunition for Indian Army by Private Indian vendors.

Purpose of the RFI

2. To identify prospective vendors for participating in the proposal for life extension of all variants of Smerch ammunition and facilitate preparation of Request for Proposal (RFP).

Overview of the Ammunition

3. <u>Smerch Rocket Variants</u>. 300mm SMERCH Rockets of following four (04) variants are used with SMERCH Multi Launcher Rocket System (MLRS) of the Indian Army, which are proposed to be offered for Life Extension by Private Indian vendors:-

4. <u>Technical and Operational Parameters</u>. The technical and operational parameters of the 300mm SMERCH Rocket ammunition are attached as per following details:-

 Likely Quantity. To be intimated during pre-submission meeting. Exact quantities will be included in the RFP.

Overview of Life Extension Methodology

6. <u>Life Extension Procedure</u>.

- (a) The LE methodology of any ammunition depends on its design configuration, composition and quantity of explosives and electronic/ electrical components. It is based on visual inspections, climatic tests, static proof in laboratory, disassembling and testing of components including safety and arming mechanism, warhead/ submunitions including their chemical analysis, etc and thereafter dynamic firing of selected ammunition. The ibid tests are conducted, as applicable, based on the methodology prescribed by the OEM and/ or QA agency.
- (b) Based on results of the tests conducted, repair, if required, and sentencing of ammunition is carried out for the duration the shelf life is to be extended.
- (c) The first Life Extension is planned in the last year of the OEM stated shelf life of the ammunition. Subsequent Life Extensions may also be conducted, as the life extension of an ammunition system is generally planned up to double the service life of the ammunition.

7. <u>Life Extension Technology</u>.

- (a) The life extended 300mm SMERCH Rockets (04 Variants) for use with SMERCH Rocket System of Indian Army as mention above will have to meet all specifications of in-service ammunition procured from Foreign OEM (M/s ROE, Russia).
- (b) The prospective vendors will be free to select their technology partners, negotiate and obtain transfer of technology (ToT). The technology partners could be indigenous DPSU/ DRDO/ any foreign vendor. Indian Army and MoD will have no liability in ToT agreements between the participating vendor and their ToT partners.
- (c) Sample of the above rockets are available various Ammunition Depots of Indian Army. Vendors desirous of seeing the sample may approach the undersigned at the contact available mentioned at Para 17.
- 8. <u>Life Extension Infrastructure</u>. The Govt of India will neither provide any special concessions nor any funding/ investment to facilitate setting up requisite infrastructure by participating firms.

Selection/ Short Listing Process

- 9. The selection and procurement process will follow the provisions of DPM 2009.
- 10. **RFP**. The RFP is proposed to be an Open Tender Enquiry (OTE) on two bid system.

- 11. **<u>Financial Evaluation</u>**. The financial evaluation of participating companies will be based on the under mentioned aspects:-
 - (a) <u>Consolidated Turnover</u>. ₹ 10 Crore for each of lastJKcopier three financial years based on financial statements audited under the relevant Companies Act and adopted and approved by the board of directors/shareholder (excluding NBFCs and any associate company)
 - (b) <u>Net Worth</u>. Net Worth at gross book value as specified in the last consolidated financial statements audited under the relevant Companies Act and adopted and approved by the board of directors/shareholders (excluding NBFCs and any associate company) of ₹ 10 Crore.
 - (c) <u>Credit Rating</u>. Applicant Company to have minimum credit rating (long term/issuer rating) equivalent to "BBB" as on the date of the application by any of the credit rating agencies approved by Securities and Exchange Board of India (SEBI).

(d) Other Conditions.

- (i) Promoters and directors of the Applicant Company and the Segment Group Co. should not be willful defaulters to the banking system or their loans from banks and financial institutions have been classified as non-performing assets by such institutions as on the date of the application. They should not be listed on exporters' caution list of the Export Credit Guarantee Corporation or be otherwise banned or blacklisted by Reserve Bank of India ("RBI"), GoI, other government agencies and Public Sector Undertakings etc. in the context of procurement or otherwise. This should be supported by a certificate(s) of the statutory auditor(s).
- (ii) The applicant company or the segment company shall not be under Corporate Debt Restructuring Mechanism ("CDR")/ Strategic Debt Restructuring Scheme/ Joint Lender Forum's corrective action plan, as prescribed by the RBI at the time of submission of application; and their account with any bank is not classified in 'Non-performing asset' category at the time of submission of the application. The above should be supported by a certificate(s) of the statutory auditor(s).
- 12. <u>Technical Evaluation</u>. The technical evaluation is proposed to be a two stage process verification of technical documentation submitted with the bid in response to RFP, followed by evaluation of the life extension process and scope of work by participating vendor or by ToT partner. In addition a technical committee to evaluate ability of bidders to undertake life extension of the rockets may be formed by IHQ of MoD (Army), under the aegis of DGQA. The parameters of such evaluation if included, will be elaborated in the RFP.
- 13. <u>Commercial Evaluation</u>. Commercial evaluation will only be carried out for firms who have qualified in all respect the technical evaluation.

Contract and Deliveries

14. The selected vendor, post technical and commercial evaluation and thereafter signing of contract, will be provided with appropriate number of rockets of each variant for carrying out Life Extension as per laid down timelines, on NCNC basis. To facilitate the same initial proofing, testing and firing ranges/ facilities will be provided to the vendors at a cost to be borne by them. The acceptance of rockets by Army's QA/QC agency will be by lots as per acceptance test procedures negotiated during the contract negotiations. These will include documentation to ensure process QC.

RFI Response Requirements

- 15. Indian vendors interested in participating in the proposal may forward their inputs to cover aspects as per RFI questionnaire at **Appendix 'B'**.
- 16. <u>Licensing/ Clearances</u>. The participating firms must be in possession of a valid explosive license or should have applied for the same, *the details of which will be submitted along with RFI response*. The firms will be responsible to obtain necessary clearances from MHA (under Arms Act), and any other permissions necessary for Life extension of 300 mm SMERCH rockets.
- 17. <u>Clarifications/ Queries</u>. Last date for submission of queries and clarifications is **M + 15 Days**. Communication received after **1600 Hr (4:00 PM)** on **M + 15 Days** will not be responded. Respondents should provide details of their contact person's telephone & mobile Nos, Fax, email and full address(s) to ensure that replies to queries to RFI can be conveyed promptly. If MoD/ Army, in its absolute discretion deem that the originator of the question will gain an advantage by a response to a question, then MoD/ Army reserves the right to communicate such response to all respondents. 18. <u>Industry Interaction/ Pre-Submission Meeting</u>. After issue of RFI, a briefing of interested manufactures will be carried out on **M + 20 Days** at **1100 Hr** at **Room No. 243**, **MGS Conference Hall** to further enumerate the Indian Army's requirement and clarify any queries that will enable fielding of response.

- 19. **RFI Response Submission**. The response to RFI must be submitted in a sealed cover along with an application duly signed and stamped on all pages by an authorized signatory. The same must reach on or before **M + 40 Days** in the following manner: -

- (b) If required additional copies may have to be submitted on request.
- (c) The response should be in English language and font size 12 (including text for footnotes, headers etc).
- (d) Submission after the due date and time may **NOT** be accepted.
- 20. <u>Completeness of Response</u>. Prospective vendors are advised to study all the RFI documents carefully. Submission of documents shall be deemed to have been done after careful study and clear understanding of its implications. The response on previous experience must showcase the vendors capability to execute the proposal (similar assignments, expertise, skill sets etc).
- 21. **Right to Terminate the Process**. The MoD/ Army reserves the right to issue a corrigendum to RFI, withdraw the RFI or/and reject any request for tender document or not to proceed with subsequent stages without assigning any reason at any stage.
- 22. <u>Ownership Rights</u>. All submissions, including any accompanying documents, will become the property of MoD/ Army. Recipients shall be deemed to be granted all rights to reproduce whole or any portion of their submission for the purpose of evaluation, to disclose the contents of the submission to other recipients who have registered a submission and to disclose and/or use the contents of the submission as the basis for any resulting RFI process, notwithstanding any copyright or other intellectual property right that may subsist in the submission or accompanying documents.
